CHILE CAPITAL The Colonel Heatedly Resents Some Remarks by Dr. Martinez in Regard to the Monroe Doctrine.

DEMONSTRATION MADE AGAINST THE COLONEL

Students Show Disapproval of Roosevelt Temper—His Speeches Edited by South American Legations.

Washington, December 21.—Members of the diplomatic corps of the South American countries, were greatly interested in a report reaching here, according to which former President Roosevelt and Dr. Marcel Martinez, at one time Chilean minister to the United States, had clashed at Santiago de Chile on account of divergent views on the Monroe doctrine. The Chilean government has strongly dissented from the Roosevelt view that the much discussed doctrine still is a vital issue.

The reported debate attracted unusual interest here, because both of the prepared speeches were reviewed before delivery by the Chilean foreign office. Dr. Martinez it was said tonight at the Chilean legation, was selected as the spokesman of the Chilean government at the state reception given the American visitor recently at the University of Santiago because of his warm friendship for the United States. He is one of the oldest and most eminent Chilean diplomats and made many lasting friendships during his tenure as minister here many years ago.

Willingness to cooperate fully will disarm in advance every factor inimical to a fair and rational adjustment.

NEW AUTO LAW HAS STRIKING CHANGES

Motorcyclists Up in Arms Over Having to Pay \$5 Each Year—Will Test the Law.

There is probably no act of the recent legislature which received such scanty public attention at the time of its passage and has aroused such general interest, as has the automobile annual registration law, which goes into effect January 1.

The license tax is increased from \$2 to \$5, and is made an annual tax instead of being good for the life of the machine as heretofore.

It is not a tax on the owners of machines as such, as a good many people writing to the secretary of state for information seem to think, but a tax on the machines themselves. The owner for two or three machines may not buy a single tax for all of them, but must furnish one self with a tag for each machine.

As to the revenue that may be collected under the operation of the new law, Mr. Cook reports that there are now registered in the state under the old law approximately 24,000 cars.

Commenting on this feature of the bill, Secretary of State Phil Cook says: "It seems to me that under the present law the state is not getting practically anything. If the state is not going to spend the money itself, there should be some means devised of helping it to do so."
