### FIFTEEN TRAPPED IN NEW YORK FACTORY FIRE

#### 50 GIRLS LEAP TO DEATH FROM FLAMES

NEW YORK, Oct. 24.—Four bodies were recovered at 5:30 o'clock this afternoon and eleven more are believed to still be in the six-story factory building at No. 128 Canal street, which was wrecked by an explosion at a clock.

Five hundred men and women were in the structure when the flames started. They attempted to escape by stairs and fire escapes. More than a score finding themselves trapped on the second floor fire escape, leaped to the street. Four of these, two boys and two girls, are dying. Others were seen to jump back into the flames.

Vincenzo Kargul, an employee of one of the firms occupying the building, climbed down the fire escape with his clothing ablaze. He said a score of flames swept through the factory, and he feared several of his shopmates had been burned to death.

#### Train Goes Through Bridge Weakened by Rain; Fireman Hurt

One man was injured and several hundred dollars damage was done Friday morning when a freight train of the Atlanta, Birmingham and Atlantic Railroad plunged into Tillman's Creek, near Manchester. The tracks over the creek had been weakened by rains.

Fireman Levi Holley was caught in the wreckage and is reported seriously hurt. Other members of the train crew jumped and escaped without injury. The engine, tender and several freight cars piled up in the creek. Trains will be delayed by way of Woodbury, an additional distance of 15 miles, until the wreck is cleared and the tracks replaced.

#### Train of Mrs. King as Accomplice in Slaying to Begin Monday.

Macon, Oct. 24.—A Jones County jury will decide to-night or to-morrow the fate of Nick Wilburn for the murder of James King, the farmer with whose wife he was infatuated.

The arguments closed this afternoon about 5 o'clock. Attorney Dean Newman opened for the defense this morning and was followed by Attorney Jackson and Johnson for the State. This afternoon Solicitor Pettie concluded for the prosecution and Attorney Cooper for the defense.

A sudden change was made to-day in the plans of the defense when Wilburn decided that he did not want to take the stand and tell the jury about the killing of King.

No testimony by defense.

Wilburn had carefully planned a statement, asserting self-defense and denying the confessions, but his counsel advised him that there was no element of self-defense in his case as indicated by the testimony. Wilburn then decided that he had better remain silent. Consequently, the defense did not offer any direct testimony and allowed the evidence submitted by the State to go to the jury unchanged except for cross-examination.

Attorney Cooper made a motion for a mistrial upon the conviction of King, on the ground that W. L. McNeill, one of the jurors, was related to Mrs. King, but he was overruled.

Mrs. King's trial Monday.

Judge Park announced from the bench that the trial of Mrs. King will start Monday morning. Her attorney, Miss Estor W. McNeill, of Macon, states that she will positively take the stand.

"She has nothing to hide," he said, "and I am confident that when the jurors hear her remarkable statement, the most remarkable that I have ever heard, they will unhesitatingly find her not guilty."

Mrs. King will not offer any witness in her behalf, unless character witnesses are presented. Mr. McNeill did not decide yet whether or not he will pursue this course, but he believes now that he will simply submit testimony to the jury.


The most damaging testimony that the State will offer against Mrs. King is a sworn confession made the day of her arrest.

Court Admits Confession.

A sworn effort was made by the defense yesterday afternoon to keep from the jury the confession made by Wilburn on the night of his arrest, while he was being hurried through the woods to Macon to escape mob violence last December. It was argued by Attorney Cooper that the confession was wrung from the defendant by threats and intimidation. Judge Park allowed the confession to go to the jury, as it was related by County Treasurer Birtwistle.

#### ATLANTA'S PREJUDICE AS BITTER AS RUSSIA'S DECLARES ATTORNEY

Reuben B. Arnold, in the opening argument of the defense in behalf of a new trial for Leo M. Frank Friday afternoon in the library of the State Capitol, made a dramatic comparison of the Frank trial with the "ritual murder" trial now in progress in Kieff, Russia.

Attorney Arnold declared that as horrible as it is that travesty on justice in Kieff, that in Atlanta last August was no less horrible. He made a bitter commentary upon the prejudice and mob spirit with which he said the defense was confronted at every turn.

"We have had to contend against two hydra-headed propositions," he said, "Prejudice and ignorance, the twin evils. We have had to contend with the spirit of the mob. This is no idle dream, but a fact of which your honor is well aware. We have been so drummed by prejudice and by hatred that their menacing influence has been constantly present in the court."

"The civilized world has been horrified by what is going on in Kieff, Russia, but it is not much stranger than this trial which was conducted in our great city."

A vigorous assault upon the character and reputation for truthfulness of men who swore against A. H. Henslee and Marcellus Johning, jurors in the Frank trial, and an equally vigorous defense of the two men who are accused of bias and prejudice, were made by Solicitor Dorsey Friday afternoon at the hearing on a new trial for Leo M. Frank in the library of the State Capitol.

WIFE TELLS OF WILBURN'S HOPE

Lawyer Pleads to Save Neck of Slayer—Verdict of Jury Near at Hand.

GRAYS, Oct. 25.—Nick Wilburn, confessed slayer of James King, a wealthy Jones county farmer, last December, has but a few hours to live until he knows whether or not he is to hang, to serve a life sentence or a limited prison term.

On the eve of her own trial, Mrs. King, in the jail here, has broken down, and with tears, made frank confessions against Wilburn, declaring that he overpowered her by force and strength and forced her to do his bidding.

RUSSIAN PERSECUTION OF JEWS CALLED MORE JUST THAN FRANK CASE

Reuben B. Arnold, of counsel for Leo Frank, resumed an address ringing with denunciation of the conditions under which Frank was convicted of the murder of Mary Phagan, when the hearing on a new trial re-convened Saturday in the library of the State capitol.

He uttered a scathing arraignment of the mob spirit which he declared had overawed the jurors and made impossible any other than that of guilty. No victim of persecution in Russia, he asserted, ever had suffered more unjustly than Leo Frank.

The attorney drew a dramatic comparison of the Frank trial with that of Mendel Beilis, the Russian Jew, whose trial in Kiev on the charge of "ritual murder" has aroused the civilized world.

Two highly-embroidered propensities which confront us at our year—prejudice and ignorance—the twin evils we have had to contend with the spirit of the mob. This is no idle dream. It is a fact of which your honor is well aware.

"The courts are organized to be spectators, not the public. The public doesn't hear the whole thing thrashed out. They are not in a position to appreciate the merits of a case, no matter how much they want to do the right thing. The law is receiving a critical test right now. I've trembled more for the law than ever before. I have thought that the law has been more on trial than Leo Frank."

"We have been so circumvented and hedged about by hatred and prejudice that their influence constantly has been felt in the courtroom where a man was guaranteed a fair and impartial trial. The day when such a condition can not exist will come. It is here now with the enlightenment of the State and even somewhat with the enlightened."

"We've got the best people on earth right here in this Southland. We really are the only American people. It will not be long before we are completely freed of all this prejudice. But this time, I am sorry to say, is not yet here. If one may judge by what occurred at the conference during the trial last August, when mobs were pushing their way into the courtroom to interfere, when people rejoiced and smiled and threw up their caps in delight because a man was condemned to death."

"I don't believe there is another man on record that a wreath composed of witness the commission of a crime against nature and fled in each of four successive affidavits on material points in his story, where his evidence would have been taken against that of a sheep-killing dog."

"Yes, you would believe the incense lies told against this man now under a sentence of death in the Tower. You would believe the charge of perversion, as base as the ever was heard in a courtroom. The investigating committee, consisting of Congressman Webb, Floyd Volstead, and others, was called to convene in Washington next Saturday, November 16, to begin hearings in Georgia at Macon, Savannah, Augusta and Albany—the four cities where the court sits.

Twenty notes are contained in the charges against Judge Speer, filed with the House by Congressman Clayton, chairman of the House Judiciary committee. He is accused of appointing his son-in-law, A. H. Hayward, to lucrative court assignments; allowing friends in awaiting his services; abuse of authority of the office; violation of the jury law and other unlawful and improper acts.

Huff Case Figures.  
The charges against Judge Speer are largely the result of the attack made on him by Colonel William A. Huff, whose estate has been in the hands of the court for more than a decade. Colonel Huff carried his complaint to members of Congress and the Department of Justice. Special agents were sent to Georgia, who investigated his political record for many years back. After their report was made to Washington the move for a Congressional investigation took shape.

BITTERLY ASSAULTS GROUND SQUAD

They Were a Pack of Wolves Thirsting for Blood, Frank Lawyer Tells Court.

His language amounted in bitterness as he progressed, Reuben R. Arnold took up again Saturday afternoon the argument in behalf of a new trial for Leo M. Frank, on which he had been engaged during the middle of the afternoon Friday at the hearing in the State Capitol.

"The jury," he observed, "was perfectly willing to swallow anything—the more improbable and grotesque, the better. No evidence was worth a haubere before that scowling, vicious mob. They were pack of wolves thirsting for blood."

Says Dorsey Misrepresented.

# DEFENSE LAWYERS DORSEY READY TO BEGIN FINAL REHEARING BATTLE

For nearly an hour the attorneys wrangled over the meaning of the word "employed" in one of the reasons. The defense held that the court had erred in permitting over the objections of the defendant the testimony of Detective Black that Frank had employed counsel the Monday morning after the crime.

Dorsey objected to the wording, saying that there was nothing in the record to warrant the use of "employed." After this one word had been discussed as effectively as a difference over an extremely vital point, a compromise was reached by revising the paragraph of Black's evidence to read that Frank "had counsel the Monday morning after the murder."

J. W. Coleman, spokesman of the murdered Mary Phagan, was an interested spectator as part of the morning session. He was on hand when the hearing opened, and remained listening intently to the debate of opposing counsel until the middle of the forenoon.

Starnes and Black Present. Detectives Starnes and Black, who were assigned to Solicitor Dorsey to work under his direction on the investigation into the Phagan murder mystery, have been in constant attendance since the hearing began Wednesday.

Frank's lawyers sprang a surprise in the last of their long string of reasons, holding that by the State's theory Jim Conley was an accomplice and that his testimony therefore could not be accepted except as corroborated by the circumstances or by another witness. The solicitor contended that he had not considered this proposition, but would be prepared to talk on it later in the hearing.

The reason charged that the court erred in not instructing the jury that if they believed from the evidence that Conley watched for Frank at the pencil factory door, and that his purpose in watching was to protect Frank in the commission of acts which constitute a felony in the State of Georgia, then Conley, as to any alleged murder committed in the progress of any such attempt to commit the acts that were described by the next's would be an accomplice, and the jury would not give him credence unless he was corroborated by the facts and circumstances or by another witness.

The announcement that the temper of the crowd about the courthouse on the closing day of the trial was such that grave fears were entertained for the safety of Frank was one of the interesting disclosures of the hearing. Attorney Luther Ross

er, chief of counsel for Frank, asserted that they would have "taken the defendant alive" if he had gone out among them on the day the verdict was rendered, particularly if an acquittal had been brought in.

Tate Advantage of Absence. Solicitor Dorsey contended that Frank in the courtroom at the time the verdict was rendered and now were taking advantage of it to claim that their client would have been mobbed or lynched had he been there when, as a matter of fact, there was no way of proving that Frank might have received not even a hostile demonstration.

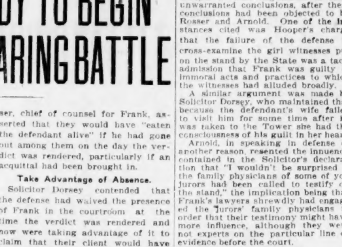
A warm dispute arose over this contention, during which it developed that the court was adjourned in the midst of Dorsey's concluding argument Saturday noon to permit the intense feeling to subside, and that later Frank's presence at the rendering of the verdict was waived by its attorneys at the suggestion of Judge Roan himself. Judge Roan had been addressed by the editors of the three Atlanta newspapers, militia officials and the chief of the police department, and urged, it was claimed, to take every precaution for the safeguarding of the prisoner, against whom there was unmistakably hostile sentiment.

The hostile sentiment against Frank was emphasized in many of the reasons advanced for a new trial. To most of them Judge Roan certified as they were submitted. The trial was taken from its outset, and notes made of every outbreak inside and outside the courtroom. The evasions received by Solicitor Dorsey were described minutely, and the occasions of applause and cheering inside the courtroom when Dorsey scored a point were stressed repeatedly.

Crowd Gets Signal. Attention also was called to the jeers and derisive laughter that met many of the arguments of Frank's lawyers. From first to last, Frank's counsel contended, it was most evident that the defendant was not obtaining the fair and impartial trial guaranteed by the law. The jury was coerced into giving a verdict of guilty and would have dared give no other verdict, according to the evidence.

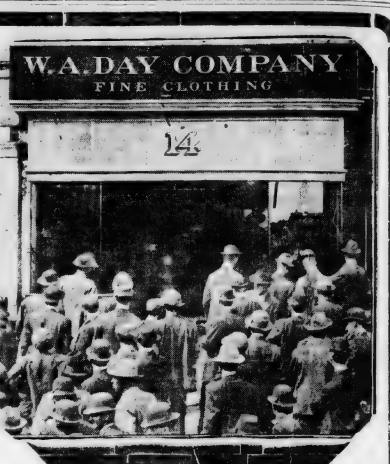

The board of health meeting called to inform the members of the factories where women are employed, he said. A special committee will be appointed to make an official probe.

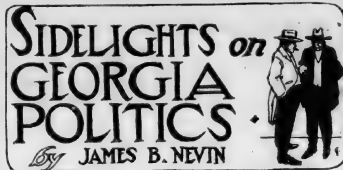
### Ogling Starts Fight In Picture Theater; Belligerents Fined

The Georgia Federation of Colored Women's Clubs has presented the Railroad Commission a petition that likely will receive the careful attention of that honorable body, and is almost sure to produce results commendable and worth while.

These colored women, who represent in their federation the best element of negro population in Georgia, do not think that their cut-off section of the ordinary cars used for colored passengers should be made virtually a smoking car, which now it often is, particularly in view of the fact that they are not permitted to use any other car, and they do not believe that it is right for them to be deprived of lavatory privileges, as they now almost invariably are. They hold that the sexes, at least, should be separated in these cars.

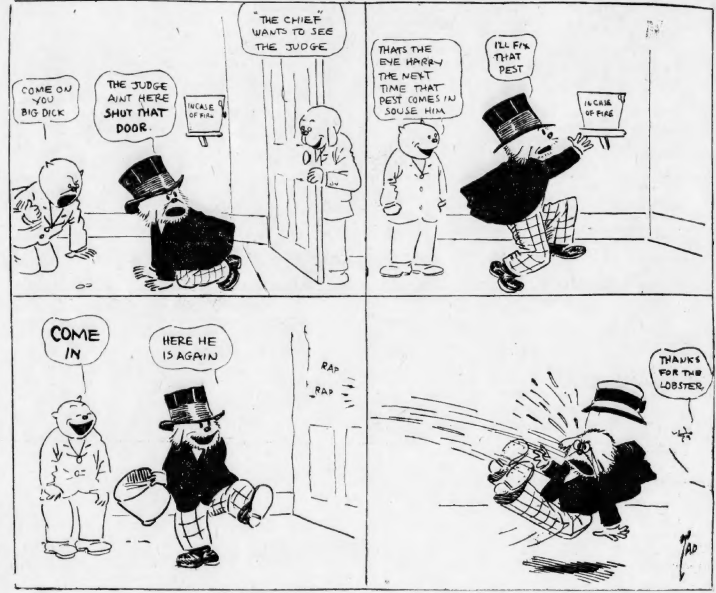

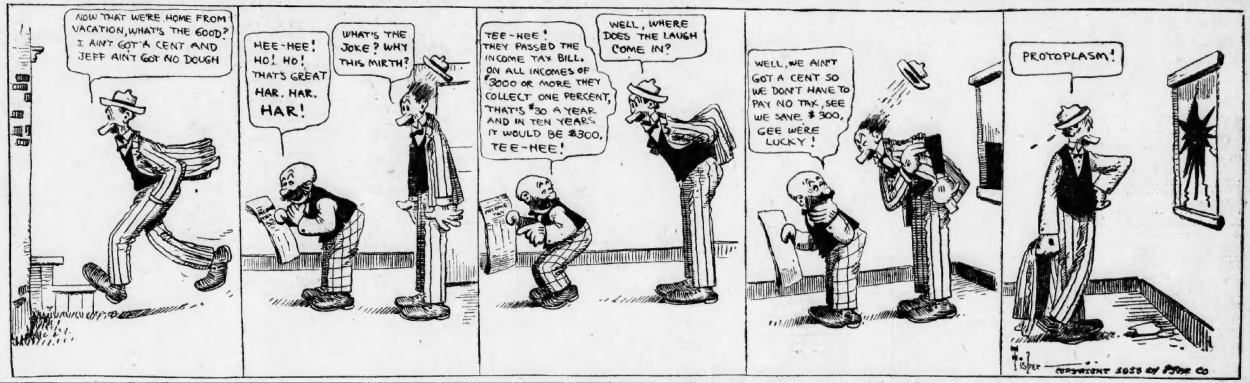
